Indirect – lap dancing, virtual sex, dominatrixDirect – saunas, clubs, hotels, flats, massage,brothels, escort services and films


 There is also the distinction of On – street and off-street sex work,

On-street sex work

- Usually British born sex workers
- However, there has been an influx of Romanian women doing on-street work...
- Strong links in the literature about homeless and drug use and sex work, particularly on –street work
- Can be targeted by law enforcement


Off-street workers

- Working indoors
- More hidden than on-street workers
- May be independent or work from an agency
- Less likely to use drugs, however, sometimes drug use may still be a problem
- Overall less prone to risk than on-street workers

what is stigma and empowerment?


stigma – a social construct ...

"an attribute that is deeply discrediting" where the stigmatized person is reduced "from a whole and usual person to a tainted, discounted one" (Goffman, 1963 cited by Yang et al, 2006)




Challenges from stigma


- Increased isolation


